

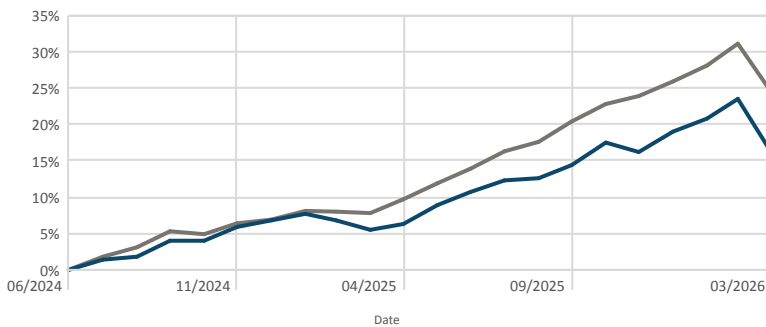
INVESTMENT OBJECTIVE

The ID Capital BCI Balanced Fund aims to provide investors with a moderate long term total return.

INVESTMENT POLICY

The portfolio's net equity exposure will not exceed 60% of the portfolio's net asset value. Investments to be included in the portfolio may comprise of assets in liquid form, money market instruments, interest bearing instruments and securities, bonds, debentures, corporate debt, equity securities, notes, property securities, preference shares, convertible equities and non-equity securities. The portfolio may from time to time invest in listed and unlisted financial instruments, in accordance with the provisions of the Act. The portfolio may invest in participatory interests or any other form of participation in portfolios of collective investment schemes or other similar collective investment schemes.

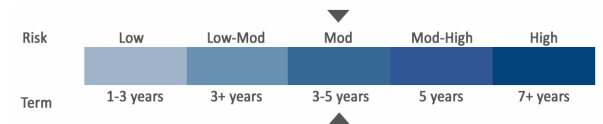

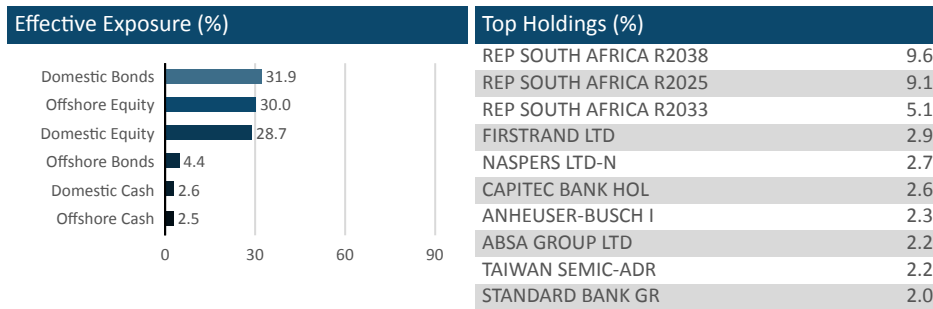
Moderate Risk
