

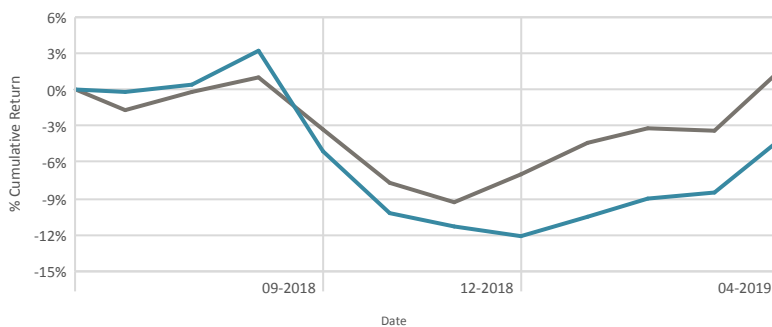
## INVESTMENT OBJECTIVE

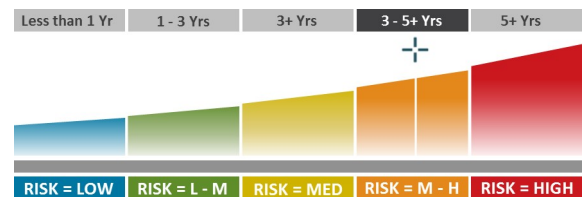

### Medium - High Risk

- This portfolio holds more equity exposure than a medium risk portfolio but less than a high-risk portfolio.
