INVESTMENT OBJECTIVE

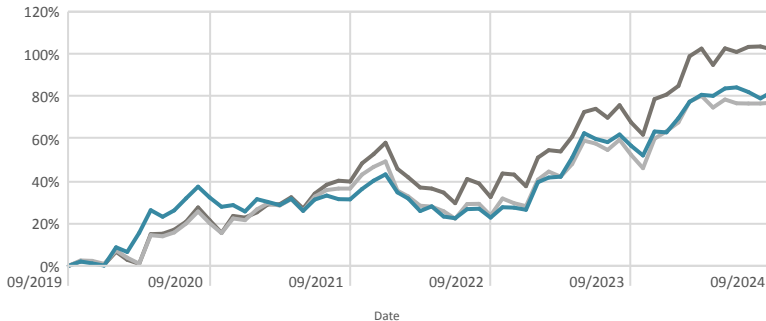
The Instiit BCI Global Equity Fund is a global equity portfolio with the objective to provide investors with high long-term capital growth.

INVESTMENT POLICY

The portfolio's investment universe will, apart from assets in liquid form, consist of equity securities, property securities, preference shares, non-equity securities, interest bearing securities and instruments. The portfolio's equity as well as global exposure will always be in excess of 80% of its net asset value. The portfolio may also invest in participatory interests or any other form of participation in portfolios of collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments. The manager may also include forward currency, interest rate and exchange rate swap transactions.

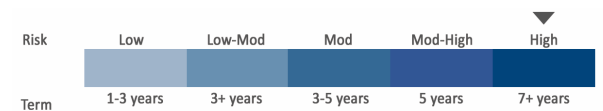
