

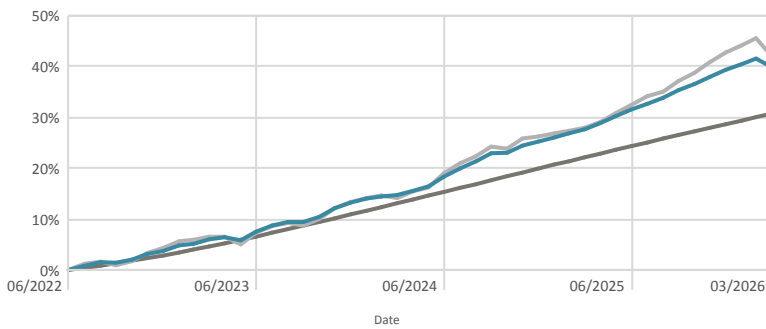
INVESTMENT OBJECTIVE

The Instiit BCI SA Flexible Income Fund is a domestic income generating portfolio with the objective to achieve a high level of sustainable income.

INVESTMENT POLICY

The investments universe of the portfolio includes South African instruments and securities of an interest-bearing nature, including bonds, inflation linked bonds, fixed deposits, loan stock, debentures, notes, debenture bonds, unsecured notes, financial instruments and any other domestic non-equity securities. The portfolio may invest in participatory interests or any other form of participation in portfolios of collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments. The manager may only include the following unlisted financial instruments for efficient portfolio management purposes: interest rate swap transactions.

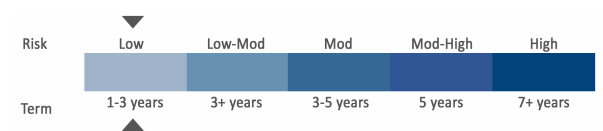
