

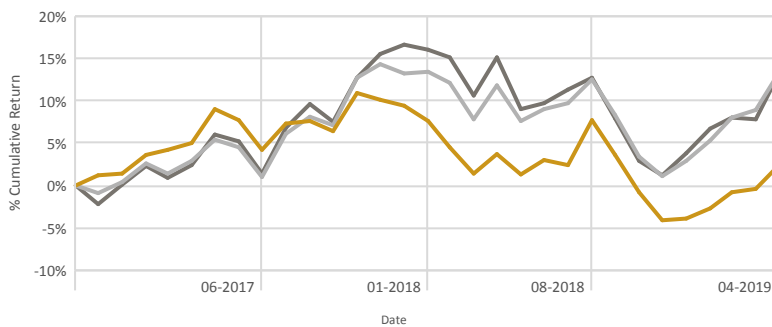
INVESTMENT OBJECTIVE

The Integral BCI Equity Fund is a general equity portfolio that seeks to sustain high long-term capital growth.

INVESTMENT UNIVERSE

This fund mirrors the successful longstanding Integral investment houseview. The portfolio's equity exposure will always exceed 80% of its net asset value. Offshore exposure cannot exceed 25% plus an additional exposure of 5% in Africa. The portfolio's investment universe consists of equity securities, preference shares, interest bearing securities, non-equity securities, property shares and property related securities listed on exchanges and assets in liquid form. The portfolio may from time to time invest in listed and unlisted financial instruments.

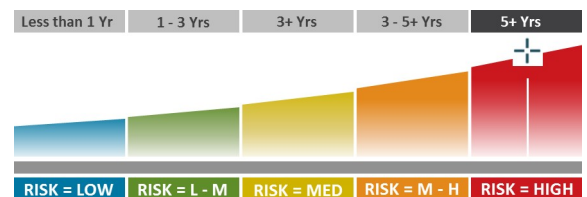

High Risk
