INTELLIVEST FR MODERATE FUND (A)

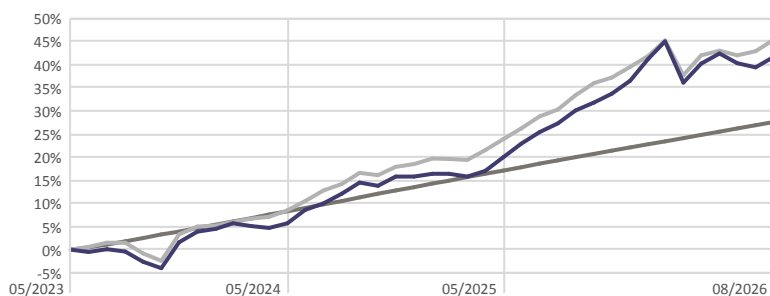
INVESTMENT OBJECTIVE

The Intellinvest FR Moderate Fund aims to provide investors with a moderate long term total return.

INVESTMENT POLICY

The portfolio is subject to a maximum equity exposure of 60% of the portfolio's net asset value. The investments normally to be included in the portfolio may comprise a combination of assets in liquid form, money market instruments, interest bearing instruments and securities, bonds, debentures, corporate debt, equity securities, notes, property securities, preference shares, convertible equities and non-equity securities. The portfolio may also invest in participatory interests and other forms of participation in portfolios of collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments.

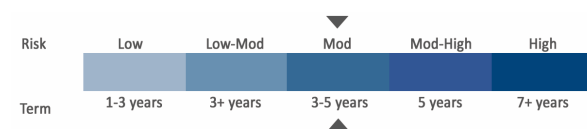

Moderate Risk

- This portfolio has a balanced exposure to various asset classes. It has more equity exposure than a low risk portfolio but less than a high-risk portfolio. In turn the expected volatility is higher than a low risk portfolio, but less than a high-risk portfolio.
