

INVESTMENT OBJECTIVE

The Mazi BCI Inflation Beater Fund aims to provide investors with inflation beating long term total returns over any rolling 12-month period at relatively low volatility levels.

INVESTMENT POLICY

This will be achieved through active asset allocation and by limiting the portfolio's equity exposure to maximum 30% of the portfolio's net asset value. The portfolio is managed in compliance with prudential investment guidelines for retirement funds in South Africa to the extent allowed for by the Act. To achieve its objective, the investments normally to be included in the portfolio may comprise a combination of assets in liquid form, equity securities, notes, property securities, preference shares, convertible equities, interest bearing instruments and non-equity securities. The portfolio may invest in participatory interests or any other form of participation in portfolios of collective investment schemes or other similar collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments, in accordance with the provisions of the Act.

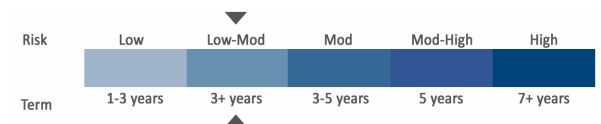

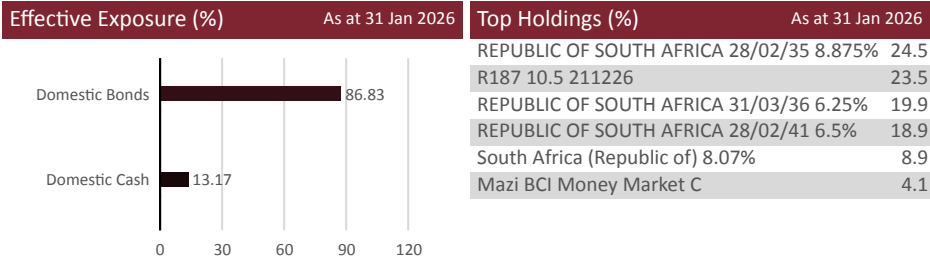
Low - Moderate Risk
