INVESTMENT OBJECTIVE & POLICY

The Methodical FR Dynamic Income Fund aims to generate returns above the SteFI + 2% p.a over time, utilising active bond management combined with strategies which aim to reduce risk. The fund is managed with a medium-term investment horizon. The fund employs a risk-focused, multi-style investment approach with a valuations bias to identify opportunities across the full spectrum of fixed income assets. The portfolio's investments will normally comprise a combination of liquid assets, including but not limited to government bonds (nominal and inflation-linked), corporate credit (primarily senior bank debt and SOEs), money market instruments, and listed property, subject to the limits of the ASISA South African Multi-Asset Income category. The portfolio may from time to time invest in listed and unlisted financial instruments, in accordance with the provisions of the Act and the Regulations thereto, as amended from time to time, in order to achieve the portfolio's investment objective. The manager may also include forward currency, interest rate, and exchange rate swap transactions for efficient portfolio management purposes.

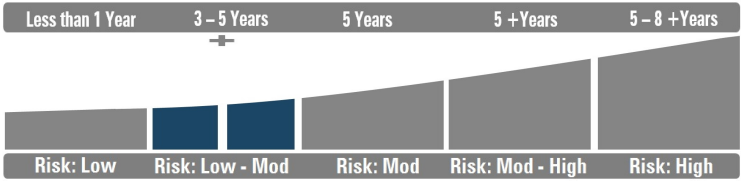

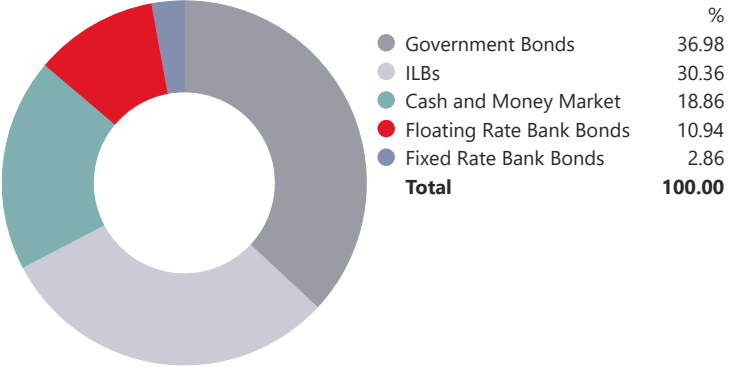
RISK PROFILE RANGE
