

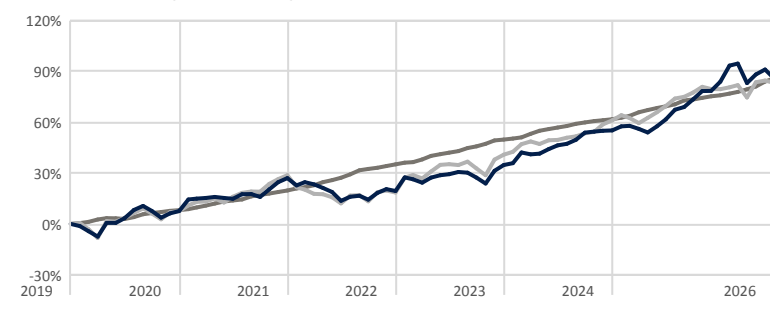
INVESTMENT OBJECTIVE

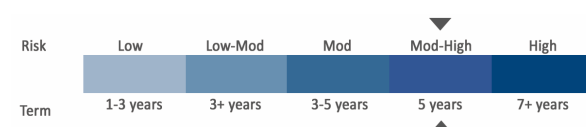
