

## INVESTMENT OBJECTIVE

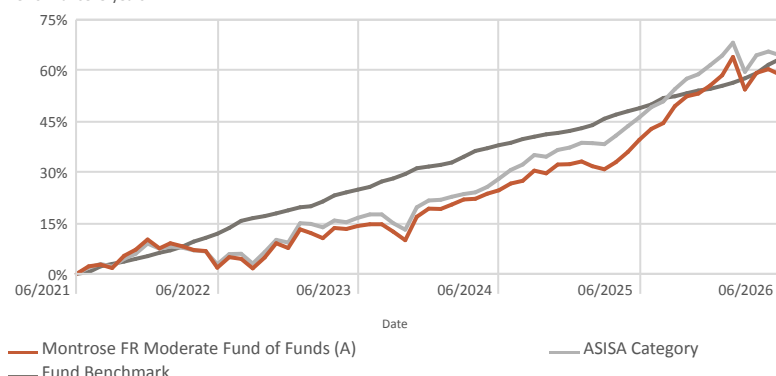
The primary investment objective of the portfolio is to provide the investor with moderate levels of income and long term capital.

## INVESTMENT POLICY

The Montrose FR Moderate Fund of Funds is a specialist portfolio with the objective to secure consistent real total returns in excess of inflation plus 5% p.a. over any rolling 3 year period. In selecting underlying portfolios for this portfolio and in determining the portfolio asset allocation, the manager shall seek to achieve this objective, where possible, regardless of stock market trends.

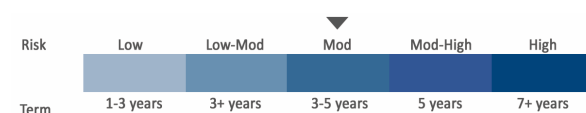

## Moderate Risk

- This portfolio has a balanced exposure to various asset classes. It has more equity exposure than a low risk portfolio but less than a high-risk portfolio. In turn the expected volatility is higher than a low risk portfolio, but less than a high-risk portfolio.
- Where the asset allocation contained in this MDD reflects offshore exposure, the portfolio is exposed to currency risks.

- The portfolio is suitable for medium term investment horizons.

- The portfolio has a high exposure to derivative instruments which may carry additional risks

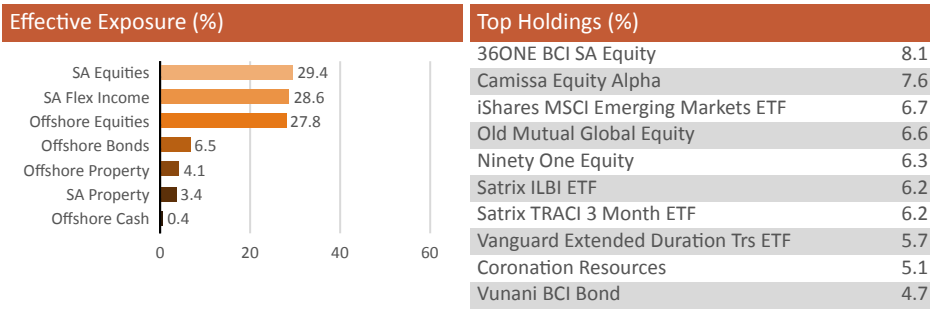
