

**INVESTMENT OBJECTIVE**

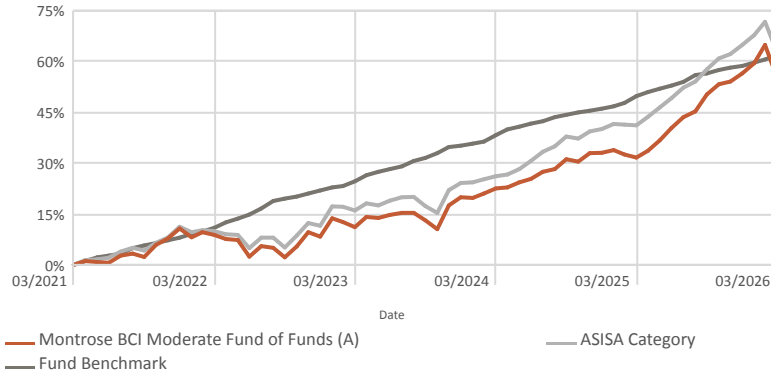
The primary investment objective of the portfolio is to provide the investor with moderate levels of income and long term capital.

**INVESTMENT POLICY**

The Montrose BCI Moderate Fund of Funds is a specialist portfolio with the objective to secure consistent real total returns in excess of inflation plus 5% p.a. over any rolling 3 year period. In selecting underlying portfolios for this portfolio and in determining the portfolio asset allocation, the manager shall seek to achieve this objective, where possible, regardless of stock market trends.

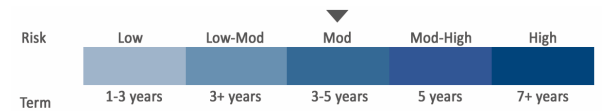

**Moderate Risk**
