

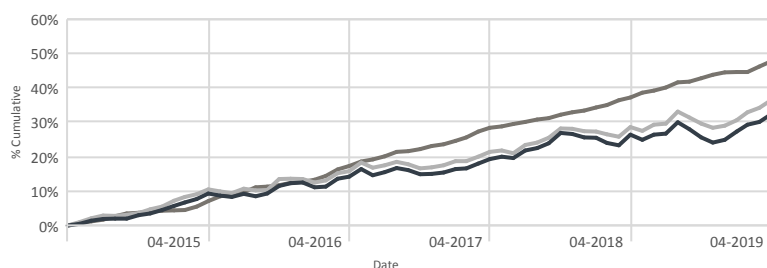
### INVESTMENT OBJECTIVE

The Naviga BCI Secure Growth Fund of Funds is a low equity prudential fund of funds portfolio. The primary investment objective of the portfolio is to provide the investor with a moderate to high level of income while preserving capital in real terms. The portfolio's maximum net equity (incl. international equity) will never exceed 40% of the portfolio's market value.

### INVESTMENT UNIVERSE

The composition of the portfolio shall reflect the investment structure of a retirement fund with a cautious risk profile and will comply with prudential investment guidelines. The Portfolio invests in a combination of collective investment schemes which invest in equities, bonds, money market instruments and property. Asset allocation is actively managed within the portfolio to ensure balance between market participation and capital preservation.

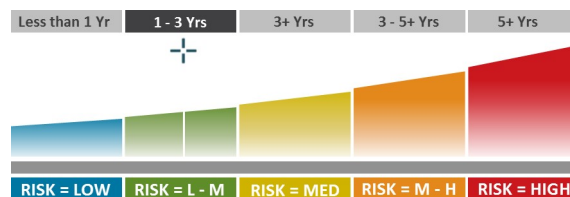
