

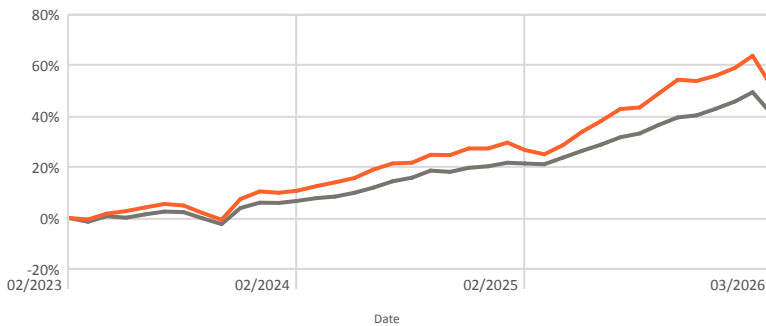
**INVESTMENT OBJECTIVE**

**INVESTMENT POLICY**

The New Road BCI Enhanced Opportunities Fund is a managed portfolio with the objective of providing investors with a moderate to high long term total return by investing in passive strategies and where suitable investment opportunities arise, enhance such strategies by investing in local and global investment opportunities. In order to achieve its objective, the investments normally to be included in the portfolio may comprise a combination of assets in liquid form, money market instruments, interest bearing instruments and securities, bonds, debentures, corporate debt, equity securities, notes, property securities, preference shares, convertible equities and non-equity securities. The portfolio may invest in participatory interests or any other form of participation in portfolios of collective investment schemes or other similar collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments.

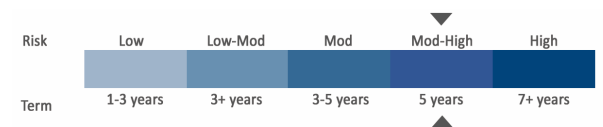

**Moderate - High Risk**
