



INVESTMENT OBJECTIVE

The Northstar FR Multi-Asset Growth Fund of Funds aims to achieve moderate to high long term capital growth.

INVESTMENT POLICY

The portfolio is managed in compliance with prudential investment guidelines for retirement funds in South Africa to the extent allowed for by the Act. Investments included in the portfolio consist, apart from assets in liquid form, of participatory interests and other forms of participation of local and global collective investment schemes, or other similar schemes operated in territories with a regulatory environment which is to the satisfaction of the manager and trustee of a sufficient standard to provide investor protection at least equivalent to that in South Africa and which is consistent with the portfolio's primary objective, investing in amongst others equity securities, property securities, non-equity securities, money market instruments, preference shares, listed and unlisted financial instruments, bonds and other interest bearing instruments and securities. The manager may enter into financial transactions for the exclusive purpose of hedging should the assets in the portfolio be exposed to exchange rate risk.

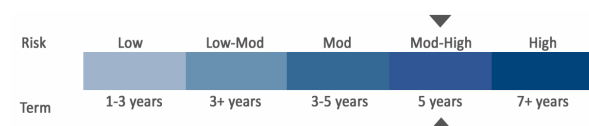

Moderate - High Risk
