

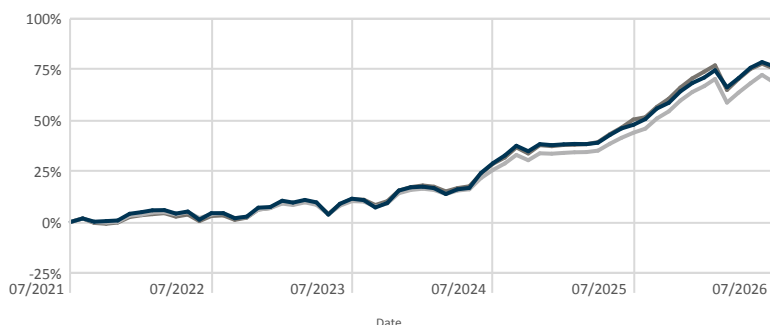
INVESTMENT OBJECTIVE

The Oakhaven FR Bond Fund is an actively managed income portfolio, that invests predominantly in domestic bonds, with the aim to provide investors with a high level of sustainable income while securing capital growth.

INVESTMENT POLICY

The investments normally to be included in the portfolio comprises a combination of assets in liquid form and a combination of bonds and interest-bearing securities and instruments, including loan stock, debentures, debenture bonds, money market instruments, notes, corporate debt and non-equity securities. The portfolio may also invest in participatory interests or any other form of participation in portfolios of collective investment schemes or other similar collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments.

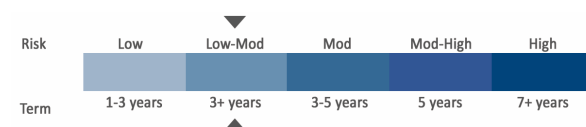

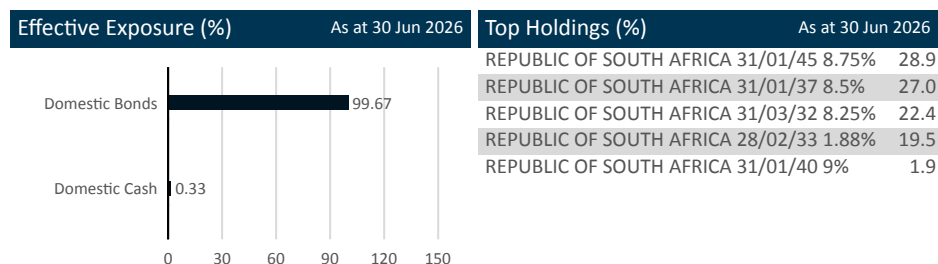
