### INVESTMENT OBJECTIVE

The Orchard BCI Diversified Fund aims to deliver long-term total return.

### INVESTMENT POLICY

The fund aims to deliver long-term total return by investing across a diversified range of assets and asset classes. The manager will seek to capture opportunities by managing the portfolio's asset allocation and equity selection. The portfolio is managed in compliance with prudential investment guidelines for retirement funds in South Africa to the extent allowed for by the Act, subject to a maximum net equity exposure of 60% of the portfolios net asset value. The portfolio may comprise a combination of assets in liquid form, money market instruments, interest bearing securities, bonds, debentures, corporate debt, equity securities, notes, property securities, preference shares, convertible equities and non-equity securities. The portfolio may invest in participatory interests or any other form of participation in portfolios of collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments.

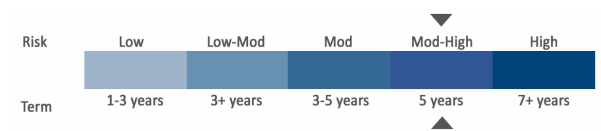
