INVESTMENT OBJECTIVE

The Platinum BCI Defensive Income Fund of Funds is an income generating portfolio with the objective to achieve a high level of sustainable income and stability of capital invested.

INVESTMENT POLICY

The portfolio's net equity exposure will be a maximum of 10% of the portfolio's asset value. Investments to be included in the portfolio will, apart from assets in liquid form, consist of participatory interests and other forms of participation of local and global collective investment schemes, or other similar schemes operated in territories with a regulatory environment which is to the satisfaction of the manager and trustee of a sufficient standard to provide investor protection at least equivalent to that in South Africa. The investments will be consistent with the portfolio's primary objective, investing in equity securities, property and property related securities, notes, nonequity instruments and securities, money market instruments, financial instruments, bonds and other interest-bearing instruments and securities.


Low Risk
