**INVESTMENT OBJECTIVE**

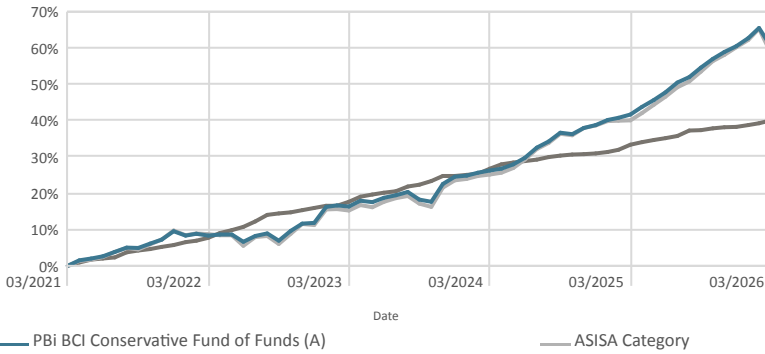
The Pbi BCI Conservative Fund of Funds is a cautious risk profiled portfolio with the objective to provide investors with a real return as well as income and capital stability.

**INVESTMENT POLICY**

This is a diversified portfolio of domestic and global asset classes. The portfolio's equity exposure may be as high as 40% of the portfolio's net asset value. Investments to be included in the portfolio will, apart from liquid assets, consist of participatory interests and other forms of participation of local and global collective investment schemes.

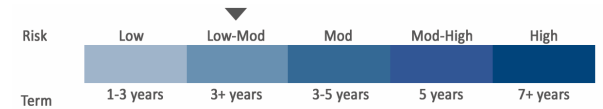
