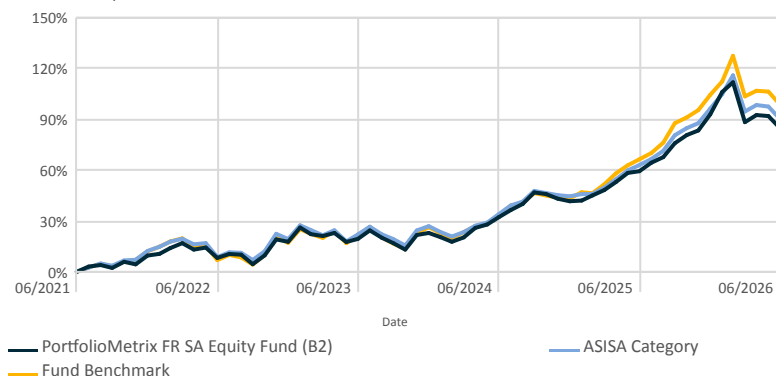
The portfolio objective is to secure high long-term capital growth.

INVESTMENT POLICY

The PortfolioMetrix SA FR Equity Fund is a domestic general equity portfolio. The portfolio's objective is to secure high long-term capital growth. The portfolio's equity exposure will always exceed 80% of its net asset value. The portfolio's investment universe consists of South African equity securities, preference shares, interest-bearing instruments, non-equity securities, property shares and property related securities listed on exchanges and assets in liquid form. The portfolio may also invest in participatory interests and other forms of participation in portfolios of collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments.

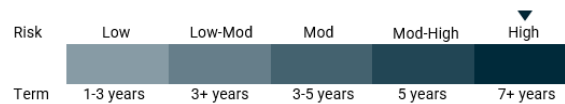

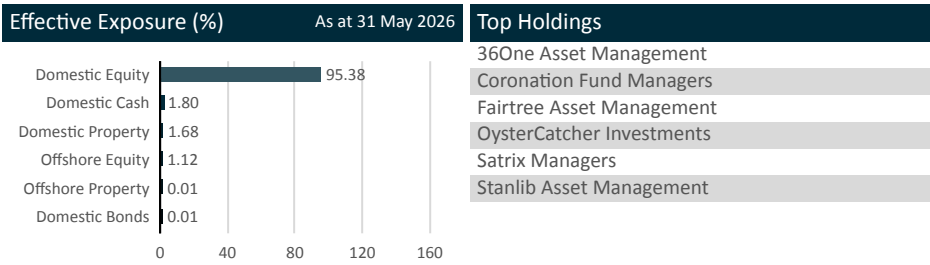
High Risk
