The Pyxis BCI Balanced Fund aims to generate a moderate to high long-term total return by investing in a diversified spread of investable asset classes.

INVESTMENT POLICY

In order to achieve its objective, the investments may comprise of a combination of assets in liquid form, money market instruments, interest bearing securities, bonds, debentures, corporate debt, equity securities, notes, property securities, preference shares, convertible equities and non-equity securities. The portfolio may invest in participatory interests or any other form of participation in portfolios of collective investment schemes or other similar collective investment schemes. The portfolio may, from time to time, invest in listed and unlisted financial instruments. The portfolio's net equity exposure ranges between 0% and 75% of the portfolio's net asset value.

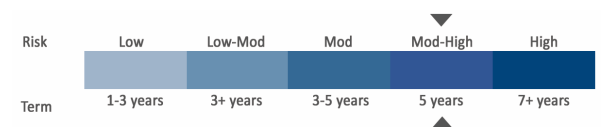

Moderate - High Risk
