

INVESTMENT OBJECTIVE

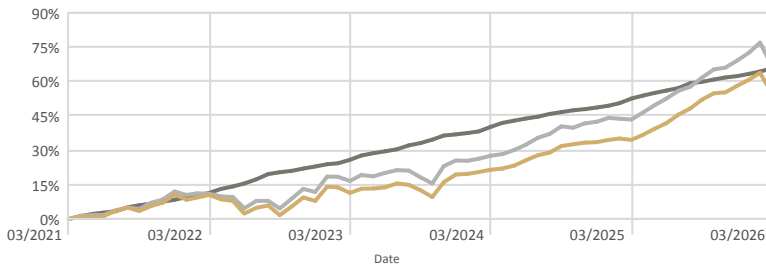
The Quantum BCI Managed Fund aims to deliver long-term capital growth with low to moderate income returns.

INVESTMENT POLICY

In order to achieve its objective, the investments to be included in the portfolio may comprise a combination of local and global equity securities, non-equity securities, money market instruments, interest bearing instruments and securities, bonds, debentures, corporate debt, equity securities, property securities, preference shares, convertible equities and assets in liquid form. The portfolio's maximum equity exposure will be 75% of its asset value. Risks will be managed by way of managing the portfolio's volatility and long term returns within acceptable risk tolerance levels with a strong emphasis on delivering long term real returns. The manager may invest in participatory interests or any other form of participation in portfolios of collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments.

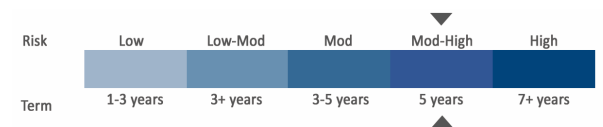

RISK PROFILE



Moderate - High Risk

- This portfolio holds more equity exposure than a medium risk portfolio but less than a high-risk portfolio.
