REMO FR GLOBAL EQUITY FUND (A)

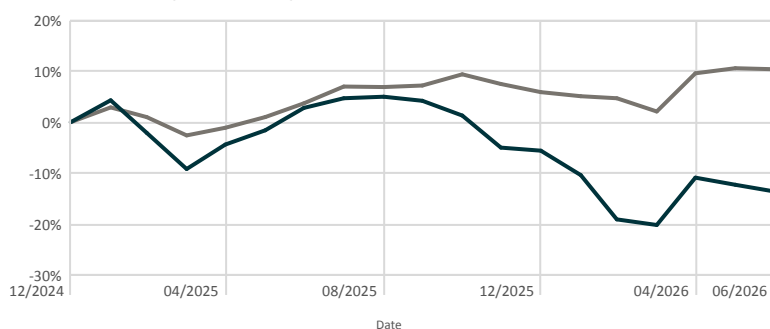
INVESTMENT OBJECTIVE

The Remo FR Global Equity Fund aims to achieve maximum long-term capital growth.

INVESTMENT POLICY

In order to achieve its objective, the investments normally to be included in the portfolio may comprise a combination of assets in liquid form, equity securities, notes, property securities, preference shares, convertible equities, interest bearing instruments and non-equity securities. The portfolio may from time to time invest in listed and unlisted financial instruments, in accordance with the provisions of the Act. The portfolio may invest in participatory interests or any other form of participation in portfolios of collective investment schemes or other similar collective investment schemes as the Act may allow from time to time, and which are consistent with the portfolio's investment policy. Where the aforementioned schemes are operated in territories other than South Africa, participatory interests or any other form of participation in portfolios of these schemes will be included in the portfolio only where the regulatory environment is, to the satisfaction of the manager and the trustee, of sufficient standard to provide investor protection at least equivalent to that in South Africa. The portfolio's foreign and equity exposure will always exceed 80% of its net asset value.

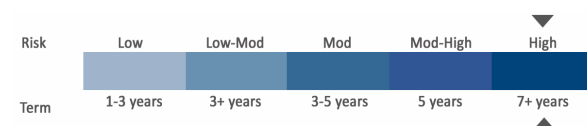

High Risk

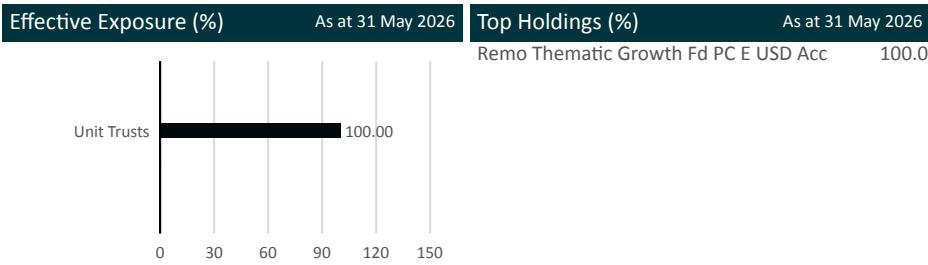
- This portfolio has a high exposure to equities and therefore tends to be more volatile than most other portfolios.
