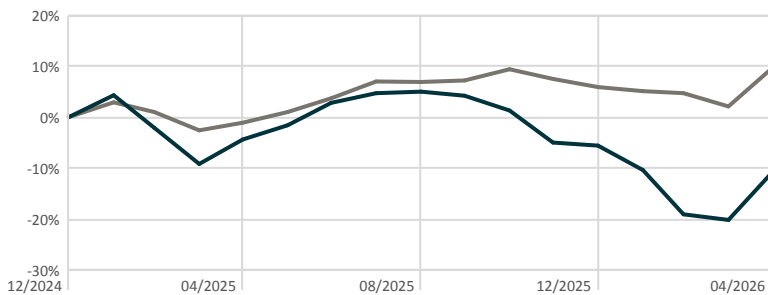
INVESTMENT OBJECTIVE

The Remo BCI Thematic Growth Feeder Fund aims to achieve maximum long term capital growth.

INVESTMENT POLICY

The portfolio will apart from assets in liquid form, invest solely in the participatory interests of the Remo Thematic Growth Fund, a cell of the SA Alpha PCC Limited, domiciled in Guernsey. The underlying portfolio aims to achieve its objective by investing mainly in global listed equity and equity related securities using a top-down thematic investment approach. To the extent that the assets in the portfolio are exposed to exchange rate risk, the manager may enter into financial transactions for the exclusive purpose of hedging such exchange rate risk subject to the conditions and limits as stipulated by the Act.

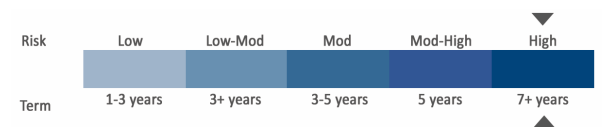

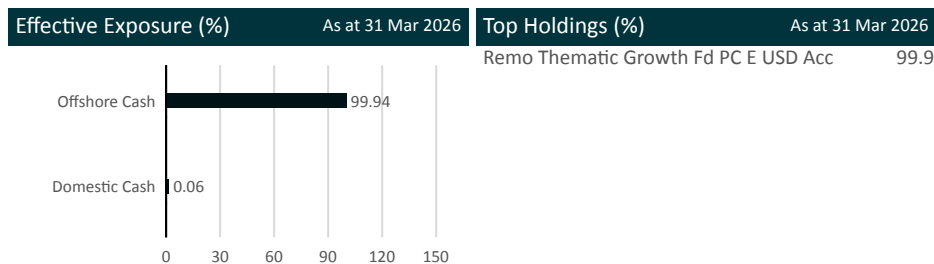
High Risk
