

INVESTMENT OBJECTIVE

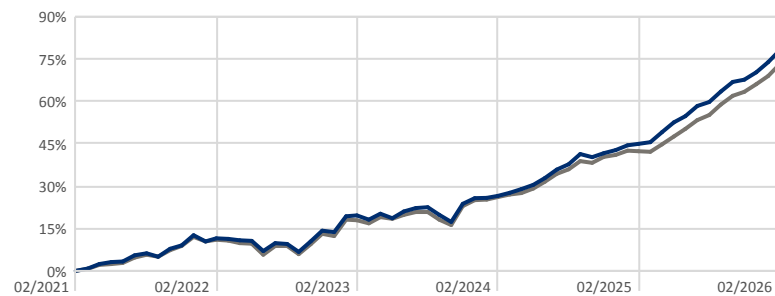
The Sage BCI Moderate Solution Fund of Funds' objective is to secure steady growth of capital, and to offer a return of at least CPI+5% over a rolling three-year period.

INVESTMENT POLICY

The portfolio's net equity exposure ranges between 0% and 60% of the portfolio's net asset value. Investments to be included in the portfolio will, apart from assets in liquid form, consist of participatory interests and other forms of participation of local and global collective investment schemes, or other similar schemes operated in territories with a regulatory environment which is to the satisfaction of the manager and trustee of a sufficient standard to provide investor protection at least equivalent to that in South Africa and which is consistent with the portfolio's primary objective, investing in, amongst others, equity securities, property securities, non-equity securities, money market instruments, preference shares, listed and unlisted financial instruments, bonds and other interest-bearing instruments and securities.

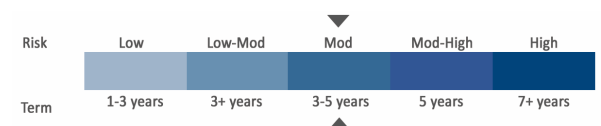

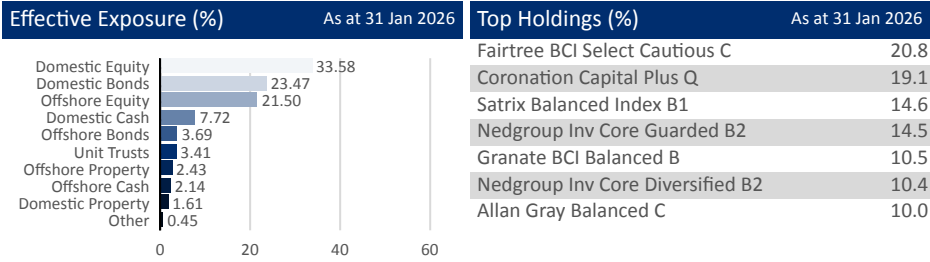
Moderate Risk
