INVESTMENT OBJECTIVE

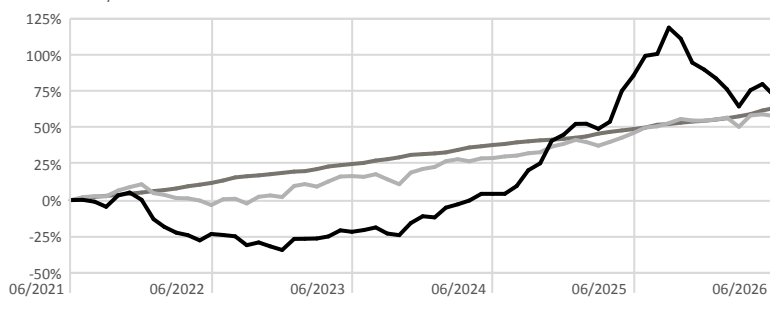
The SaltLight FR Worldwide Flexible Fund aims to provide investors with high long-term total returns.

INVESTMENT POLICY

The portfolio may invest in participatory interests or any other form of participation in portfolios of collective investment schemes or other similar collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments.

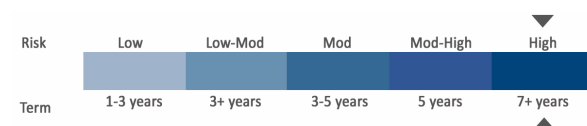
