

INVESTMENT OBJECTIVE

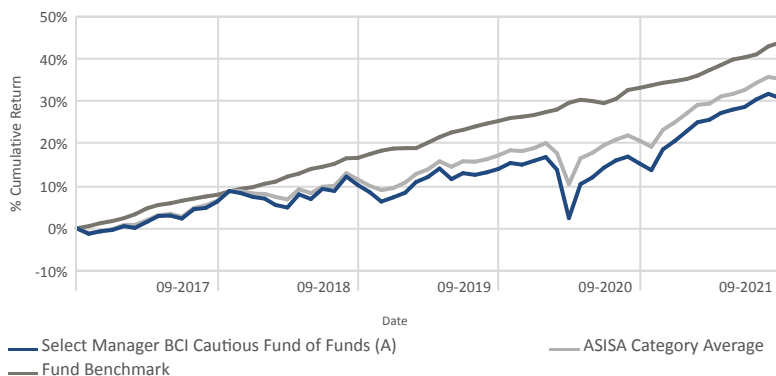
The investment objective of the Select Manager BCI Cautious Fund of Funds is to provide investors with a consistent return over the medium term with a high level of income and capital preservation.

INVESTMENT POLICY

Investments to be included in the portfolio will, apart from assets in liquid form, consists of participatory interests and other forms of participation of local and global collective investment schemes, investing in equity securities, property securities, non-equity securities money market instruments, preference shares, listed and unlisted financial instruments, bonds and other interest bearing instruments and securities. The portfolio's equity exposure will be limited to maximum 40% of the portfolio's net asset value.

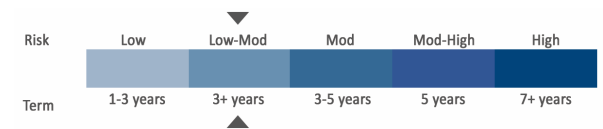
