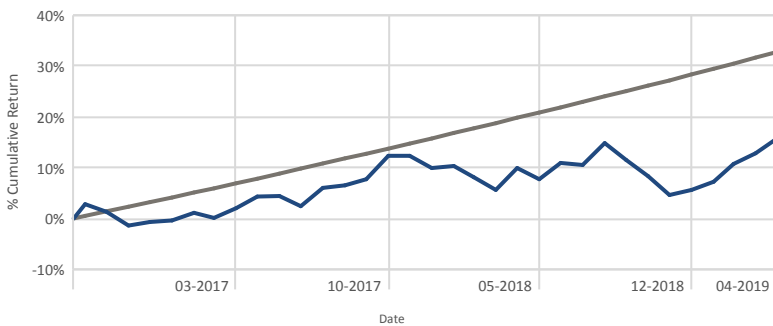
INVESTMENT OBJECTIVE

The investment objective of the Select Manager BCI Flexible Growth Fund of Funds is to provide investors with long term capital growth.

INVESTMENT UNIVERSE

The portfolio is managed in compliance with prudential investment guidelines for retirement funds in South Africa to the extent allowed for by the Act and its equity exposure will be maximum 75% of its net asset value. Investments to be included in the portfolio will, apart from assets in liquid form, consist of participatory interests and other forms of participation of local and global collective investment schemes, investing in equity securities, property securities, non-equity securities money market instruments, preference shares, bonds and other interest bearing instruments and securities.

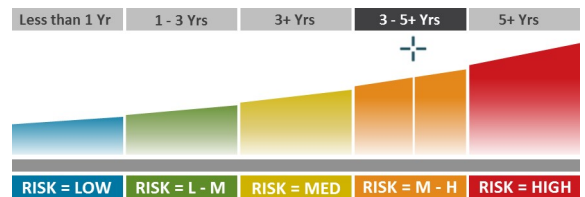

Medium - High Risk
