INVESTMENT OBJECTIVE

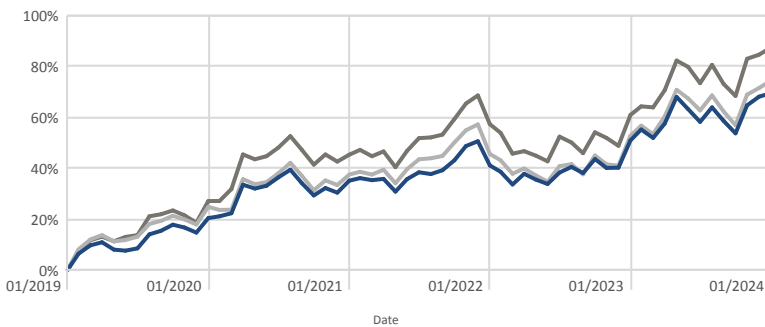
The investment objective of the Select Manager BCI Global Moderate Fund of Funds is to provide investors with a diversified exposure to global assets with a focus on steady long term capital growth.

INVESTMENT POLICY

The portfolio's minimum offshore exposure will be 80% of its net asset value. Investments to be included in the portfolio will, apart from assets in liquid form, consist of participatory interests and other forms of participation of local and global collective investment schemes, investing in equity securities, property securities, non-equity securities money market instruments, preference shares, listed and unlisted financial instruments, bonds and other interest bearing instruments and securities.

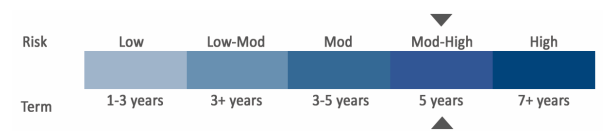
