

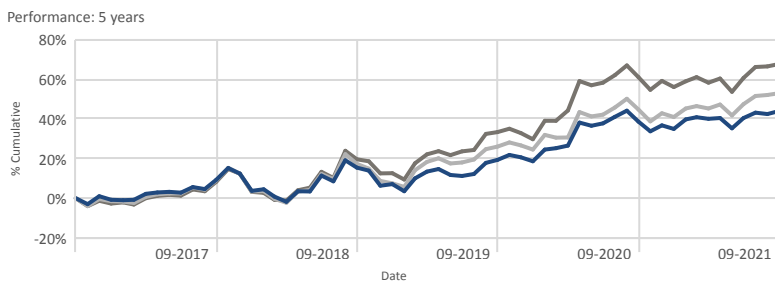
**INVESTMENT OBJECTIVE**

The investment objective of the Select Manager BCI Global Moderate Fund of Funds is to provide investors with a diversified exposure to global assets with a focus on steady long term capital growth.

**INVESTMENT POLICY**

The portfolio's minimum offshore exposure will be 80% of its net asset value. Investments to be included in the portfolio will, apart from assets in liquid form, consists of participatory interests and other forms of participation of local and global collective investment schemes, investing in equity securities, property securities, non-equity securities money market instruments, preference shares, listed and unlisted financial instruments, bonds and other interest bearing instruments and securities.

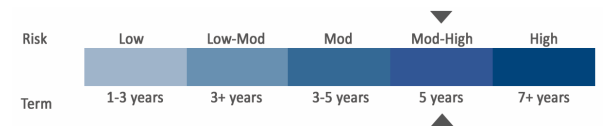

**Moderate - High Risk**

- This portfolio holds more equity exposure than a medium risk portfolio but less than a high-risk portfolio. In turn the expected volatility is higher than a medium risk portfolio, but less than a high-risk portfolio. The probability of losses is higher than that of a medium risk portfolio, but less than a high-risk portfolio and the expected potential long term investment returns could therefore be higher than a medium risk portfolio.
