INVESTMENT OBJECTIVE

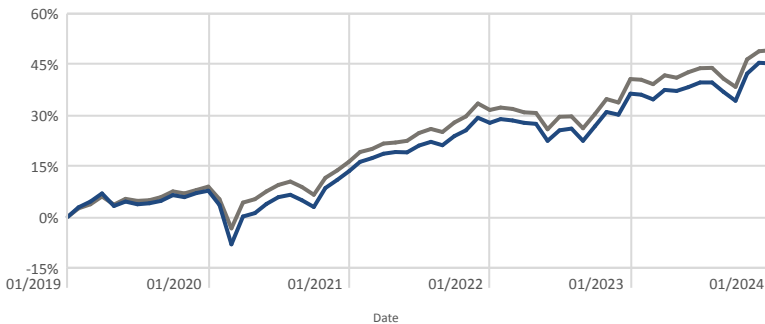
The investment objective of the Select Manager BCI Moderate Fund of Funds is to provide investors with a reasonable level of income and stable long-term growth.

INVESTMENT POLICY

The portfolio's equity exposure will be maximum 60% of its net asset value. Investments to be included in the portfolio will, apart from assets in liquid form, consists of participatory interests and other forms of participation of local and global collective investment scheme, investing in equity securities, property securities, non-equity securities money market instruments, preference shares, listed and unlisted financial instruments, bonds and other interest bearing instruments and securities.

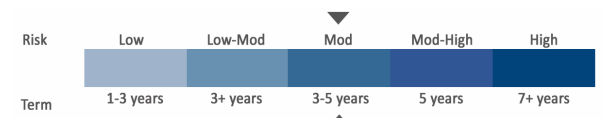
