The portfolio may from time to time invest in listed and unlisted financial instruments. The portfolio's global property exposure will always exceed 80% of the portfolio's asset value. Up to 10% of the portfolio may be invested in shares outside the property sector in companies that conduct similar business activities.

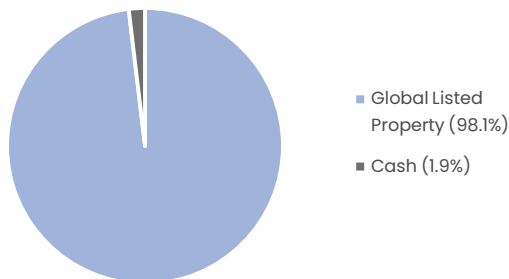

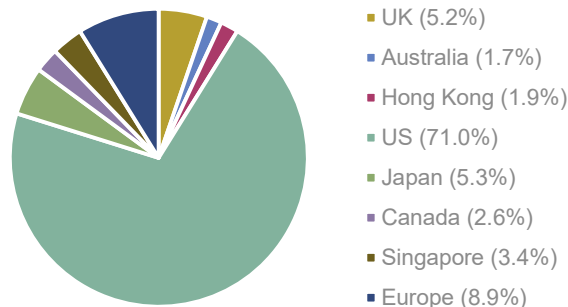

FUND STRATEGY

The Fund's objective is to deliver USD total returns that outperform the FTSE EPRA/NAREIT Developed Rental Net Index ("Index") over a 3 to 5-year investment horizon. Our macro-economic views inform our regional allocations while our sector themes inform our stock picking to deliver outperformance without exposing clients to unnecessary risk.

INVESTMENT POLICY

The policy is to invest in globally listed Real Estate Investment Trusts ("REITs") or listed property companies. The investment manager will also be allowed to invest in financial instruments and cash as allowed by the act from time to time in order to achieve its investment objective. Furthermore, and as legislation permits, the manager shall be permitted to invest in offshore listed property investments on behalf of the Sesfikile BCI Global Property Fund.

MARKET REVIEW

Global REITs (as per EPRA/NAREIT Developed Rental Index Net TR, USD; "Benchmark") closed the month down 4.2% in USD (-2.1% in ZAR) underperforming global equities (1.2%) and global bonds (-1.6%). By region, Australian and Canadian REITs generated the best performance, down 1.8% and 2.6%, respectively. Hong Kong and European REITs lagged, returning -11.2% and -5.3%, respectively.

Recent economic data suggest a "soft-landing" (slowing growth but no recession) is becoming more likely for the US economy. US GDP for Q4 2023 grew 3.3%, a full 1.3% higher than expected. In addition, core PCE (the Federal Reserves preferred measure of inflation) continued its downward trend, growing 2.9% y/y in December, the lowest since March 2021. The US job market remains tight (3.7% unemployment rate) and wages continue to grow at 4.2% year on year. The Federal Reserve (Fed) kept rates unchanged at the January policy meeting, stating "good progress" toward its goals, but inflation is still "elevated".

During the month, data centers performed best at +3.3%, driven by record leasing which drove positive sentiment. Single family residential at -1.2% came in second, driven by Blackstone's acquisition of Tricon Residential for \$3.5bn and a 30% premium to the pre-deal price. Hotels (-1.9%) and Malls (-3.2%) also outperformed as the market priced in stronger than expected economic data while defensive sectors such as self-storage (-7.8%), gaming (-6.1%) and healthcare (-5.8%) underperforming. More on M&A, Fund Manager BlackRock announced the acquisition of Global Infrastructure Partners (GIP) for \$12.5 billion. GIP is an infrastructure fund manager with over \$100 billion in assets under management and owns CyrusOne, a hyperscale data center platform with more than 50 data centers in U.S. and European markets.

Although top line rental growth remains solid, we expect global REITs to grow earnings by 4% in 2024 and a revert to the long-term average growth rate of 5% in 2025, with upside risk to our forecast. Despite recent valuation adjustments, balance sheets remain healthy with a 34% loan-to-value ratio and a manageable debt maturity profile. Global REITs trade at a 15% discount to net asset value (NAV) and offers a 4.4% dividend yield. Given current property fundamentals, macroeconomic trends, and the more dovish central bank outlook, 2024 presents a good backdrop for outperformance of global listed property. Considering these factors, we believe total returns in the region of 12% in USD are reasonable over the next 12 months.
