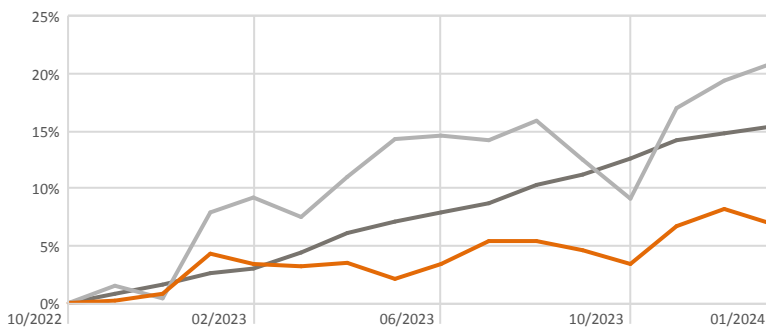
INVESTMENT OBJECTIVE

The Skyblue BCI Aggressive Worldwide Flexible Fund is a worldwide flexible portfolio with a higher than average risk profile that aims to deliver a high long term capital return.

INVESTMENT POLICY

The portfolio's minimum equity exposure is 65% of its asset value. The portfolio may invest in global and local equity securities, interest bearing securities, property shares, property related securities, preference shares, money market instruments, non-equity securities and assets in liquid form. The portfolio may also invest in participatory interests and other forms of participation in portfolios of collective investment schemes. The portfolio will invest in listed financial instruments.

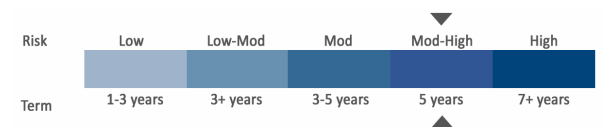

Moderate - High Risk
