

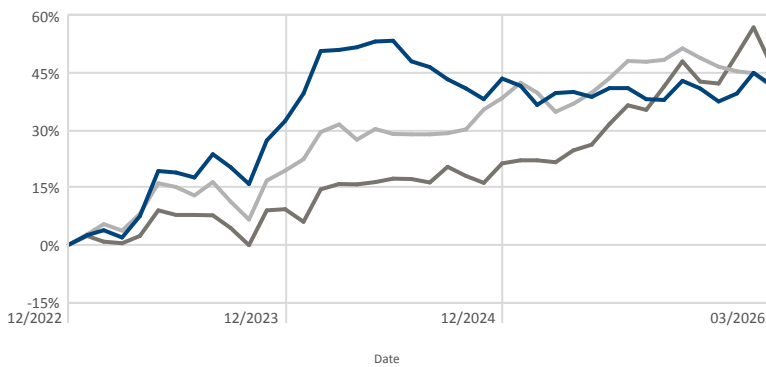
INVESTMENT OBJECTIVE

The Fund invests solely in GQG Partners Emerging Markets Equity, a sub-fund of the GQG Global UCITS ICAV, domiciled in Ireland.

INVESTMENT POLICY

The fund aims to provide investors with long term capital growth. The underlying portfolio seeks to invest in high-quality companies with attractively priced future growth prospects in emerging markets. The portfolio will apart from assets in liquid form, invest solely in the participatory interests of the GQG Partners Emerging Markets Equity Fund, a sub-fund of the GQG Global UCITS ICAV, domiciled Ireland. The underlying portfolio invests primarily in equity securities. To the extent that the assets in the portfolio are exposed to exchange rate risk, the manager may enter into financial transactions for the exclusive purpose of hedging such exchange rate risk subject to the conditions and limits as stipulated by the Act.

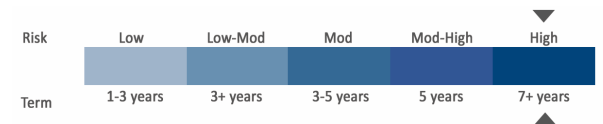

High Risk
