

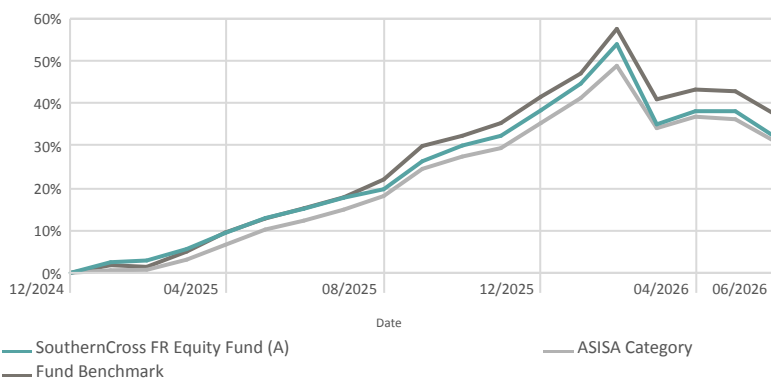
## INVESTMENT OBJECTIVE

The SouthernCross FR Equity Fund objective is to deliver a high long term total return.

## INVESTMENT POLICY

The portfolio's net equity exposure will be a minimum of 80% of the portfolio's asset value. The portfolio's investment universe consists of equity securities, preference securities, non-equity securities, notes, property shares and property related securities listed on exchanges, interest bearing securities and instruments as well as assets in liquid form. The portfolio may also invest in participatory interests and other forms of participation in portfolios of collective investment schemes or other similar schemes operated in territories with a regulatory environment. The portfolio may from time to time invest in listed and unlisted financial instruments.

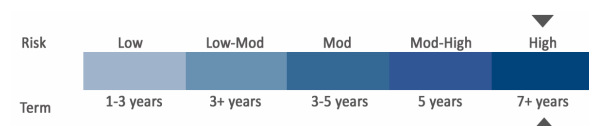
