

## INVESTMENT OBJECTIVE

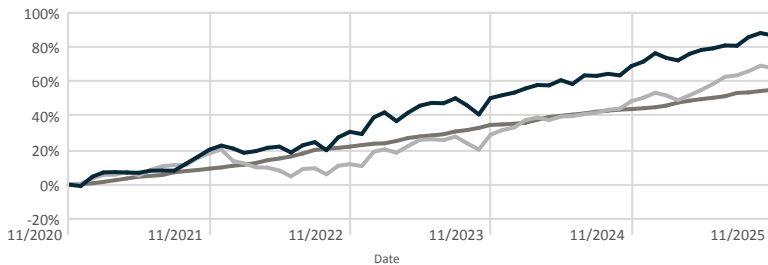
The Stonehage Fleming BCI Worldwide Multi-Asset Flexible Fund aims to provide long term investors with high long term total returns by actively managing the portfolio's underlying holdings and asset allocation.

## INVESTMENT POLICY

The strategic emphasis is to identify stocks which are trading away from long term intrinsic value. The portfolio's investment universe may include global and local equity securities, government bonds, corporate bonds and inflation linked bonds, debentures, property securities, property related securities, interest bearing securities, preference shares, money market instruments and assets in liquid form. The portfolio's equity exposure will typically constitute 70% or more of its asset value whilst never reducing below 40% of the total portfolio value. The portfolio may from time to time invest in listed and unlisted financial instruments. The manager may include the following unlisted financial instruments: forward currency swaps, interest rate and exchange rate swap transactions for efficient portfolio management purposes. 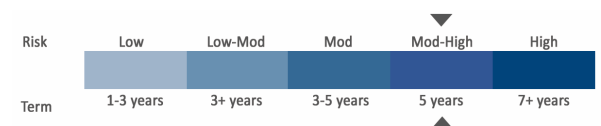

## RISK PROFILE



### Moderate - High Risk
