

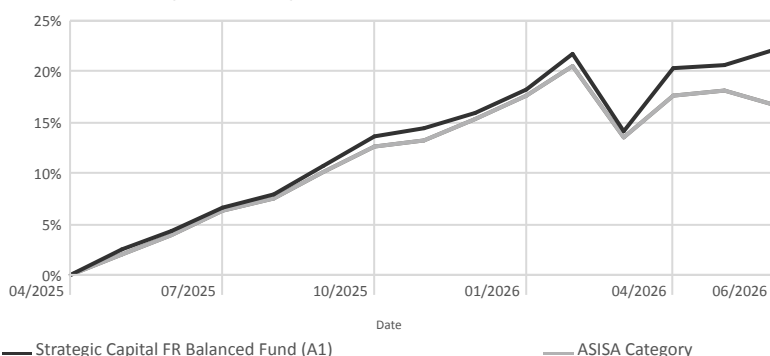
INVESTMENT OBJECTIVE

The Strategic Capital FR Balanced Fund aims to offer investors long term capital growth through a well-structured and diversified portfolio that mitigates risk and enhances returns.

INVESTMENT POLICY

In order to achieve its objective, the investments normally to be included in the portfolio may comprise a combination of assets in liquid form, money market instruments, interest bearing securities, bonds, debentures, corporate debt, equity securities, notes, property securities, preference shares, convertible equities and non-equity securities. The portfolio may from time to time invest in listed and unlisted financial instruments. The portfolio's net equity exposure ranges between 0% and 75% of the portfolio's net asset value.

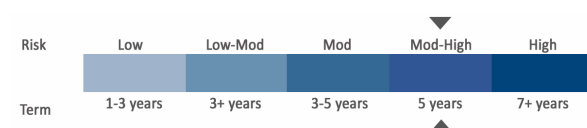

Moderate - High Risk
