

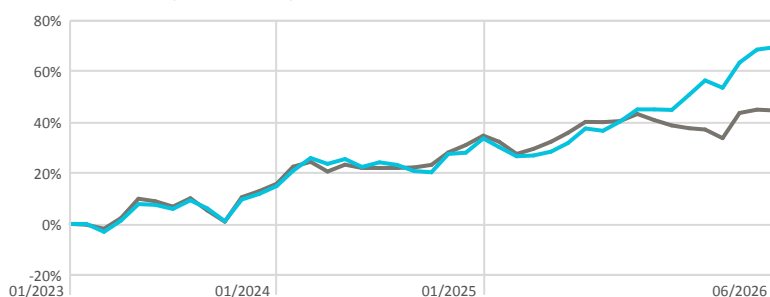
INVESTMENT OBJECTIVE

INVESTMENT POLICY

The FR T. Rowe Price Global Value Equity Feeder Fund aims to provide investors with long term capital growth. The portfolio will apart from assets in liquid form, invest solely in the participatory interests of the T. Rowe Price Global Value Equity Fund, a sub-fund of the T. Rowe Price Funds SICAV, domiciled in Luxembourg. The underlying portfolio is actively managed and invests mainly in a widely diversified portfolio of undervalued shares of companies anywhere in the world, including emerging markets and incorporate environmental, social and governance ("ESG") factors in the decision-making process. To the extent that the assets in the portfolio are exposed to exchange rate risk, the manager may enter into financial transactions for the exclusive purpose of hedging such exchange rate risk subject to the conditions and limits as stipulated by the Act.

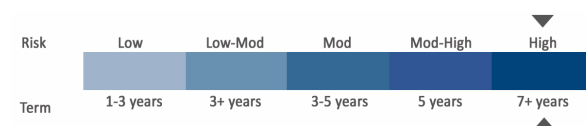

High Risk
