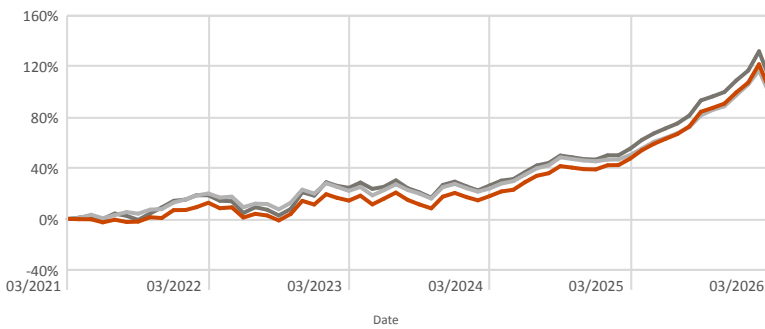
The Taquanta BCI SA Equity Fund aims to provide investors with long-term capital growth.

INVESTMENT POLICY

The portfolio's equity exposure will always exceed 80% of its net asset value and it will invest in South Africa only. In order to achieve its objective, the investments normally to be included in the portfolio may comprise a combination of assets in liquid form, equity securities, notes, property securities, preference shares, convertible equities, interest bearing instruments and non-equity securities. The portfolio may invest in participatory interests or any other form of participation in portfolios of collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments.

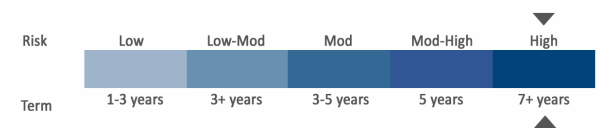

High Risk

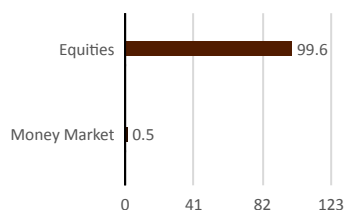
- This portfolio has a high exposure to equities and therefore tends to be more volatile than most other portfolios.
