### INVESTMENT OBJECTIVE

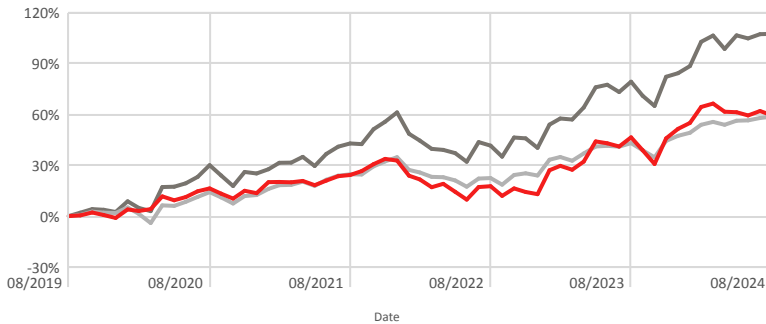
The Capital Incubator BCI Worldwide Opportunities Fund of Funds is a worldwide flexible portfolio that aims to deliver a high long-term total return by exploring investment opportunities through asset class and geographical allocations.

### INVESTMENT POLICY

The portfolio's minimum equity exposure is 50% of its net asset value. Investments to be included in the portfolio will, apart from assets in liquid form, consist of participatory interests and other forms of participation of local and global collective investment schemes. The portfolio's primary objective is, investing in, amongst others, equity securities, property securities, non-equity securities, money market instruments, preference shares, listed and unlisted financial instruments, bonds and other interest-bearing instruments and securities.

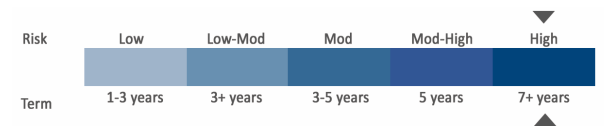
