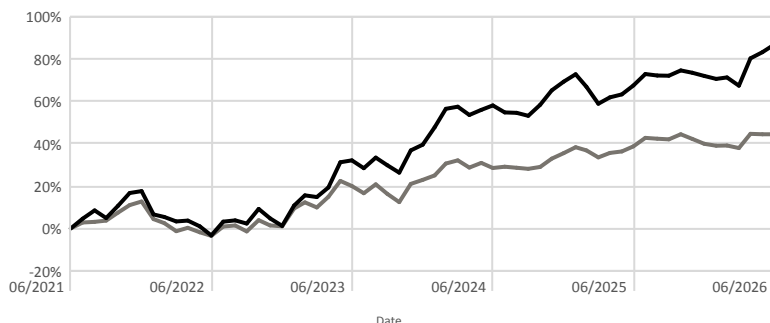
The ThinkCell FR Global Marathon Fund is a global flexible portfolio which aims to achieve long term capital growth.

INVESTMENT POLICY

The portfolio's minimum foreign exposure is 80% of its net asset value and it will typically be 80% exposed to foreign equities and 15% to foreign property securities, but the Manager will have complete flexibility to vary the exposure to different asset classes as economic conditions vary. The portfolio may comprise a combination of assets in liquid form, equity securities, notes, property securities, preference shares, convertible equities, interest bearing instruments and non-equity securities. The portfolio may invest in participatory interests or any other form of participation in portfolios of collective investment schemes or other similar collective investment schemes as the Act may allow from time to time, and which are consistent with the portfolio's investment policy. The portfolio may from time to time invest in listed and unlisted financial instruments

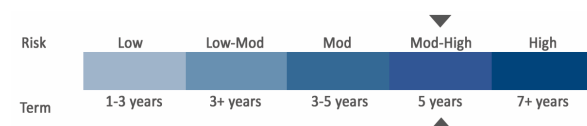

Moderate - High Risk
