

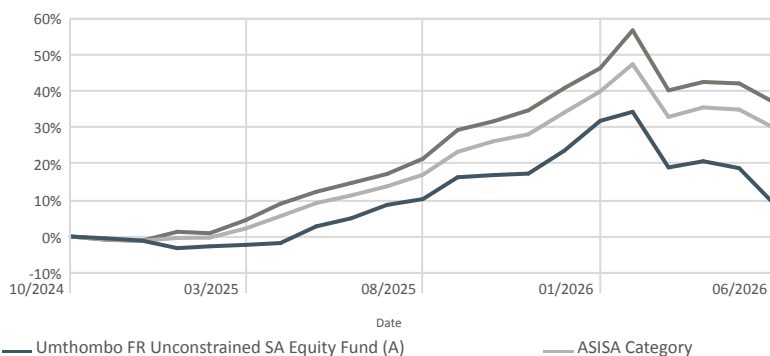
INVESTMENT OBJECTIVE

The Umthombo FR Unconstrained SA Equity Fund is an unconstrained diversified domestic equity portfolio that aims to provide investors with high long term capital growth.

INVESTMENT POLICY

The portfolio's equity exposure will always exceed 80% of its net asset value and the portfolio will not invest offshore. In order to achieve its objective, the investments normally to be included in the portfolio may comprise a combination of assets in liquid form, equity securities, notes, property securities, preference shares, convertible equities, interest bearing instruments and non-equity securities. The portfolio may invest in participatory interests or any other form of participation in South African portfolios of collective investment schemes or other similar collective investment schemes as the Act may allow from time to time, and which are consistent with the portfolio's investment policy. The portfolio may from time to time invest in listed and unlisted financial instruments, in accordance with the provisions of the Act, and the Regulations thereto, as amended from time to time, in order to achieve the portfolio's investment objective.

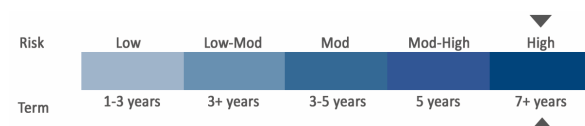
