

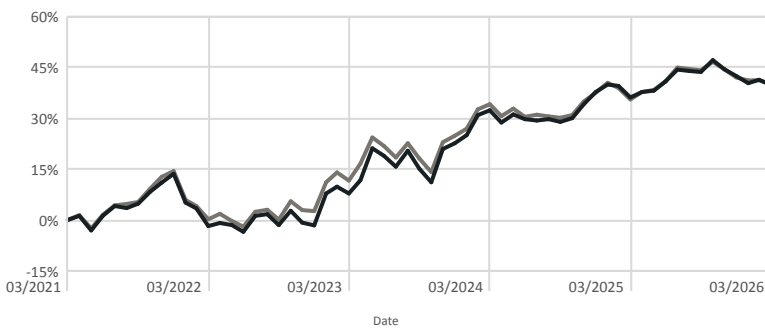
**INVESTMENT OBJECTIVE**

The Wealth Associates BCI Global Flexible Fund of Funds is a global flexible portfolio with the objective of providing investors with a high long term capital growth.

**INVESTMENT POLICY**

The portfolio's minimum offshore exposure is 80% of its net asset value. Investments to be included in the portfolio will, apart from assets in liquid form, consists of participatory interests and other forms of participation of local and global collective investment schemes, or other similar schemes operated in territories with a regulatory environment which is to the satisfaction of the manager and trustee of a sufficient standard to provide investor protection at least equivalent to that in South Africa and which is consistent with the portfolio's primary objective. The underlying portfolios may invest in, amongst others equity securities, property securities, non-equity securities, money market instruments, preference shares, bonds, other interest-bearing instruments and financial instruments.

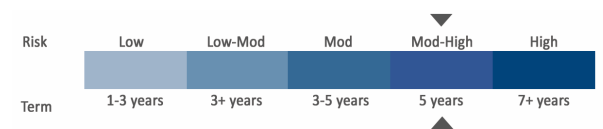

**RISK PROFILE**



**Moderate - High Risk**

- This portfolio holds more equity exposure than a medium risk portfolio but less than a high-risk portfolio.
