

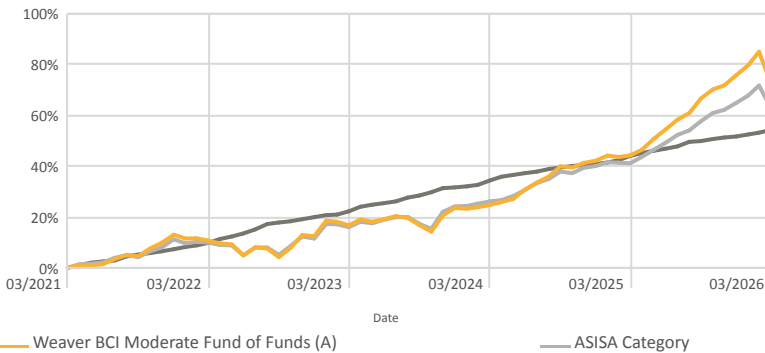
INVESTMENT OBJECTIVE

The objective is to achieve moderate capital growth in the medium to long-term combined with a reasonable level of income. The portfolio aims to achieve a return of 4% above inflation over rolling 5-year periods.

INVESTMENT POLICY

The portfolio's net equity exposure ranges between 0% and 60% of the portfolio's net asset value. Investments to be included in the portfolio will, apart from assets in liquid form, consist of participatory interests and other forms of participation of local and global collective investment schemes. The investments will be consistent with the portfolio's primary objective, investing in equity securities, property and property related securities, non-equity securities, money market instruments financial instruments, bonds and other interest-bearing instruments and securities.

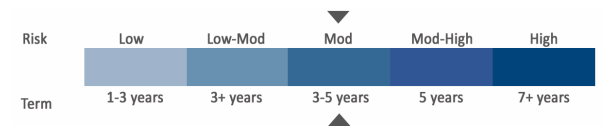

Moderate Risk
